This formulation utilizes an innovative encapsulation technology that is fast-reacting and aids in helping to break down the chemical bonds between dirt, grease, and grime. These extremely active, self-binding compounds provide maximum cleaning efficiencies by making it easier, faster, and will not allow soils to be redeposited on the floor.

ReflectiCLEAN has also been designed using a 'hydro-coating' technology that enhances the surface with each use by increasing abrasion resistance that will ultimately improve the floor's durability and performance over time.

STORAGE & HANDLING

Maintain unused product in the original container. Reflective Floor™ Wet Polishing System is a methodical process requiring the use of all certified Reflecti Floor products and Reflective Floor™ REFYNE Tooling to attain maximum results.

PREPARATION

Dry sweep floor to remove any loose debris from the area that is being cleaned using a clean micro-fiber pad dust/dry mop.

Auto-Scrubber: Affix appropriate pads.

Add fresh clean water to tank prior to adding (1) 12 oz. (0.35L) bottle of ReflectiCLEAN Concrete Cleaner. Adding water prior to cleaner will help prevent any excess creation of foam.

CLEANING DIRECTIONS

AUTO SCRUB:

Turn solution valve to full flow. Before lowering pads onto floor, allow the water to lightly soak pads to help avoid creating swirl marks.

Lower pads using medium pressure, adjust water valve to 3/4 to maximum flow. Turn vacuum on, lower squeegee blade and begin scrubbing area.

FOR HEAVILY SOILED SURFACES:

On first pass, scrub heavily soiled area with pads only, squeegee up, and vacuum off. Allow ReflectiCLEAN to stand on surface a minimum of 5 minutes. Do NOT allow cleaner to dry on the floor. Lower squeegee and vacuum up the soiled solution.

CLEAN UP // DISPOSAL

Use soap and water. Any product that cannot be saved or recycled should be triple rinsed and disposed of according to local, state, and federal regulations.

MAINTENANCE

Routine cleaning with ReflectiCLEAN Concrete Cleaner is recommended using a micro-fiber mop or auto scrubber equipped with soft pads. Do NOT use string mops. Do NOT use cleaners that have butyl compounds or citrus, these acidic cleaners will damage the floor.

HEALTH & SAFETY
